3. Only technically, legally and financially capable supplier/contractor may be allowed to join. Bidders shall submit within five (5) calendar days from receipt of the notice from the BAC that it has the lowest calculated quotation, the following documentary requirements.
 - a) Current Mayor's/Business Permit;
 - b) PhilGEPS Registration Number;
 - c) Latest Income/Business Tax Returns filed and paid through the BIR Electronic Filing and Payment System (eFPS); and
 - d) A duly accomplished Omnibus Sworn Statement in the form prescribed by the 2016 RIRR of RA 9184.; and

The PVAO reserves the right to accept or reject any offer/quotation, to reject all offer/quotation at any time prior to contract award, to exclude any item or reduce the number of units and corresponding ABC as determined by PVAO and to award the contract to the bidder with the most advantageous offer, without thereby incurring any liability to the interested entities.
