**RE-WATERPROOFING OF PKTCC ROOF DECK AT PHILIPPINE
KOREA FRIENDSHIP CENTER, BAYANI ROAD, TAGUIG CITY**

THIS AGREEMENT, made this _____ day of _____ 2019 between the **PHILIPPINE VETERANS AFFAIRS OFFICE** of the Philippines of the one part and **CONCRETE SOLUTION BUILDERS & SUPPLY** of No. 2 Luskot St. corner Matinyas St. Brgy. Don Manuel, Quezon City, of the other part:

WHEREAS the Entity is desirous that the Contractor execute the **RE-WATERPROOFING OF PKTCC ROOF DECK AT PHILIPPINE KOREA FRIENDSHIP CENTER, BAYANI ROAD, TAGUIG CITY** (hereinafter called "the Works") and the Entity has accepted the Bid for **Two Million Eight Hundred Six Thousand Eight Hundred Forty-Two Pesos & 14/100 (P 2,806,842.14)** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.


2. The following documents shall be attached, deemed to form, and be read and construed as integral part of this Agreement, to wit:


- (a) General and Special Conditions of Contract;
- (b) Drawings/Plans;
- (c) Specifications;
- (d) Invitation to Bid;
- (e) Instructions to Bidders;
- (f) Bid Data Sheet;
- (g) Addenda and/or Supplemental/Bid Bulletins, if any;
- (h) Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
- (i) Eligibility requirements, documents and/or statements;
- (j) Performance Security;
- (k) Notice of Award of Contract and the Bidder's conforme thereto;
- (l) Duly signed Construction Schedule and S-Curve, Manpower Schedule, Construction Method in detailed narrative form, Equipment Utilization Schedule, PERT/CPM Network Diagram and Health and Safety Plan.

3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.


4. The Entity hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of the Contract at the time and in the manner prescribed by the Contract.
