THIS AGREEMENT, made the _____ day of _____ 20____ between **PHILIPPINE VETERANS AFFAIRS OFFICE** of the Philippines of the one part and **COSASDEOFICINA TRADING** of Unit 206 272 Malapantao St. Barangka Itaas, Mandaluyong City, Metro Manila of the other part:


WHEREAS the Entity invited Bids for certain goods and ancillary services, particularly **Lot 2 – Supply and Delivery of Contactless Thermal Scanner and Alcohol Dispenser Set with Adjustable Stand** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **One Hundred Seventy-One Thousand Pesos (P 171,000.00)**.

 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid. Including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - iii. Performance Security;
 - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**
3. In consideration for the sum of **One Hundred Seventy-One Thousand Pesos (P 171,000.00)** or such other sums as may be ascertained, **Cosasdeoficina Trading** agrees to deliver the **Lot 2 – Supply and Delivery of Contactless Thermal Scanner and Alcohol Dispenser Set with Adjustable Stand** in accordance with its Bid.
4. The **Philippine Veterans Affairs Office** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.


