- a) Channel Requirements:

 - The CATV provider shall install eight (8) TV outlet cable connections within PVAO main office.
 - The CATV provider, in the performance of its service, shall secure and maintain at its own expense all registration, licenses or permits required by law.
 - The period covered shall be for one (1) year, from 01 January to 31 December 2022.
- c) Warranties:
 - In cases of service interruption due to either the provider's defective equipment or facilities, or causes within their control, the CATV provider shall confirm such in writing and adjust or repay a part of the charges in accordance with the mutually agreed rebate structure.
