SUPPLY AND DELIVERY OF MEDICINES FOR CY 2022

THIS AGREEMENT, made the _____ day of _____ 20____ between **PHILIPPINE VETERANS AFFAIRS OFFICE** of the Philippines of the one part and **FILADAMS PHARMA INC.** of No. 37 Mapagkumbaba St., Sikatuna Village, Quezon City of the other part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, particularly **Supply and Delivery of Medicines for CY 2022 (Item Nos. 2, 3, 7, 8, 10, 11, 14, 16, 17, 18, 19, 20, 22, 23, 24, 25, 27, 31, 34, 35, 41, 42, 44, 52 & 53)** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Eight Hundred Fifty-Seven Thousand Nine Hundred Pesos (P 857,900.00)**.




